It is our sincere hope that you have been enjoying your summer and will continue to, throughout the next few weeks.

Our staff is currently preparing for the first day of school for students on September 7th. Lincoln and Thomas Jefferson will be running on a full day schedule, including lunch. Our schools, in conjunction with the central office, will be sending out more specific information in the next few weeks including, but not limited to: upcoming events, dropoff/pickup, lunch protocols, and other important procedures that coincide with the start of the school year.

*The Road Forward* was a document that the New Jersey Department Education published in June 2021. In this document, it states that: "Local Education Agencies (LEAs) must plan to provide full-day, full-time, in-person instruction and operations for the 2021-2022 school year. The New Jersey Department of Education (NJDOE) and New Jersey Department of Health (NJDOH) worked collaboratively to develop the following guidance to operationalize that goal." Based on the guidance in the document above, all NJ school districts were required to address a safe return to in-person instruction and continuity of services. The various categories in this plan are listed below:

- Maintaining Health and Safety
- Ensuring Continuity of Services
- Public Comment

In the upcoming weeks, we will also be updating you on specific health-related procedures, including quarantining. We are currently meeting with pertinent district staff, as well as outside

agencies affiliated with the district in various capacities, to ensure accuracy (health department, etc.). The New Jersey Department of Health should also be updating their K-12 guidelines to address any revisions/additions since their last guidance.

Many of you are probably aware that Governor Phil Murphy has mandated that facemasks will be required indoors at all school buildings for students, staff, and visitors for the 2021-2022 school year. NJ.com reported, "In Murphy's Executive Order, face masks are required to be worn indoors at all public, private, and parochial preschool, elementary, and secondary school buildings, with limited exceptions."
