PART I. DISTRICT EXPECTATIONS

- 1. The <u>Rockaway Borough School District</u> will take the following actions to involve parents in the joint development of its district/school parental involvement plan.
 - Meetings-with parents, administrators, and teachers to discuss any concerns or suggestions to the plan or program in general

 - Draft of plan prepared (June 2020)

 - School faculty with input from parents will review the policy annually, and make suggestions for the next school year based upon information/data gathered
- 2. The <u>Rockaway Borough School District</u> will convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved;
 - Annual Title I (BSI/WIN) Nights are held in each district school annually in October to share timely information regarding Title I programs and how they align with district curriculum. Parents of ESL or ELL students are also invited to attend and obtain information about their targeted programs and instruction.
 - At this same time, parents are provided with an explanation of the curriculum used, the assessments used to measure student progress and eligibility, and the proficiency levels students are expected to meet.
 - Targeted staff are also asked to speak about their role in regards to programming and interventions.
 - At this meeting, as well as throughout the school and at the close of the academic year, parents are surveyed and their input is used to drive both programming and the parent involvement policy.

3. The <u>Rockaway Borough School District</u> will offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, child care, or home visits, as such services relate to parental involvement;

Daily before school from 8:10-8:30am and after school from 3:10-3:25pm in the <u>Elementary School</u> and 8:10-8:25am and 3:15-3:25pm in the <u>Middle School</u>, or at other prearranged times.

In addition to individual meetings, staff will be available to discuss programs at

- Parent Teacher Conferences
- Academic Open Houses
- Annual BSI/WIN Nights
- 4. The <u>Rockaway Borough School District</u> will provide the following necessary coordination, technical assistance, and other support to assist district schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance:
 - Central office administration (Superintendent and the Supervisor of Curriculum and Instruction) along with buildings principals meet regularly to discuss Title I programming and how to support effective parental involvement.
 - Building administration in turn collaborate with teaching staff and parents on how best to work as a team to support student progress.
- 5. The <u>Rockaway Borough School District</u> will build the schools' and parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
 - A. The school/district will provide assistance to parents of children served by the school district or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph

- Parent-teacher conferences
- Meetings with administrators to discuss these and other topics

- Written explanations and score interpretations of mandated assessments
- Parent presentations on requirements of Title I regarding Parent Involvement and related services

The <u>Rockaway Borough School District</u> will provide parents of participating children, if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to education of their children, and respond to any such suggestions as soon as practically possible.

- B. The school/district will, with the assistance of its Title I schools, provide materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by;

 - Discussing relevant strategies during monthly faculty meetings regarding the value of parent contributions and how to work with parents as equal partners
 - Educating new/novice teachers in the importance of working with parents as part of the Beyond Mentoring program
 - Sharing timely current research and journal articles with the staff as a whole whenever possible
 - Creating guidelines for parent involvement designed to aid teachers and other staff members in reaching out to, communicating with, and working with parents as equal partners. The plan calls for encouraging parents to take an active role as advocates for their children and to participate in the parent-teacher meetings.
- D. The school/district will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First,

- Creating a Kindergarten Boot Camp program with Title I funds to help transition incoming and identifiable students with targeted help prior to their start in kindergarten
- Coordinating with Early Intervention in identifying and transitioning possible Preschool students
- Working collaboratively with the school district to explore and find creative solutions for funding for potential preschool students
- E. The school/district will take the following actions to ensure that Title I information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand;
 - Provide written materials and communications in English and other targeted languages. If not, provide links for translation.
 - Whenever possible have translators available in the front office of each building and for Parent meetings.
- 6. The <u>Rockaway Borough School District</u> will coordinate and integrate parental involvement strategies under Title I with parental involvement strategies under the following programs and agencies such as Early Intervention and Head Start by...
 - Arranging periodic and timely meetings with program/agency coordinators once students have been identified.
 - Sharing pertinent information with parents in regards to future Title I services and programming
 - Provide all parties with written materials and resources to aide transitions and delivery of services
- 7. The <u>Rockaway Borough School District</u> will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I schools. - The BSI/WIN coordinator in each district school sends out program evaluations and surveys both at the beginning of the school year and then again at the end of each academic year.
- Building principals also seek input from parents in regards to targeted before and after school programs (Ready, Set, Go, After the Bell and W.I.S.E)
- Feedback and input is used regularly to drive programming as well as improve communication and delivery of information and
- 8. The <u>Rockaway Borough School District</u> will take the following actions to involve parents in the process of school review and improvement:

Throughout the year, parents are asked to provide the schools and the district with feedback regarding Title I and intervention services through surveys, group meetings and individual conferences with teachers, interventionists and administration. Information gathered is then shared with the Title I coordinator, the lead interventionist, all designated interventionists, classroom and content area teachers and all levels of administration.
