Governor's Executive Order Changes School Schedule for Election Day

Dear Parents and Rockaway Borough families

At our recent Board of Education meeting, we discussed and confirmed plans regarding Election Day, Tuesday November 3rd.

As per the Governor's Executive Order #177, all New Jersey school buildings whether they are official polling places or not, must be closed for in-person instruction. Remote learning however, may continue. Since this is already a short week due to the NJEA Teachers' Convention, the following schedule changes have been made to optimize student in-person instruction for all Cohorts.

- Monday 11/2 will be an in-person instruction day for all students in Cohorts A & C. Students will follow a regular cycle day schedule.
- Tuesday 11/3 (Election Day) will be a totally virtual instruction day for all Cohorts as dictated by the Governor. All staff except maintenance will work/teach virtually from home.
- Wednesday 11/4 will be an in-person instruction day for Cohorts B & C as per our regular hybrid schedule.
- On Thursday 11/5 and Friday 11/6, school will be closed as per our 2020-21 School Calendar for the NJEA Teachers' Convention.

If parents/families for any reason are unable to accommodate the Monday schedule change, Cohort A students may simply attend classes virtually online on November 2nd.

As always, thank you in advance for your cooperation regarding this schedule change and please stay safe and well.

Request for Change in Learning Platforms

Just a reminder as per our district Reopening Plan, parents may decide to send their students back to school for inperson instruction who are currently remote or have them switch to remote from in-person as directed by the
Governor. These transitions must take place at the end of each Marking Period. If families wish to change the learning
environment of their children, they must provide a request in writing or via email to their respective building Principal
with 10 day notice prior to the start of a new marking period. The start of the second marking period is November 11th
so building principals are currently accepting requests from parents and will do so up until the first of November.

- Receive submissions of work from students in one easily managed area
- Manage timetables, email and discussions from a personal desktop

- · Access learning materials created by teachers and others from outside locations such as the library or home
- Save work and notes online for use in assignments and homework outside of normal school hours
- Create online portfolios and performance videos
- Work at heir own pace with a wider choice of learning styles in a more personalized way
- Submit homework and assignments for grading and assessment
- Communicate by email and participate in live discussions and forums with teachers and other students

Practical Benefits to Parents and Guardians that enable them to:

- Play a greater part in their child(ren)'s learning especially when there is access from home
- · Support children in any learning that takes place outside of school
- Access their child's personal progress to keep track of their work and assignments
- View reports, attendance data and scores in assessment activities
- Communicate effectively with teachers and school administrators

- Engage with wider school issues through online communication tools
