The Board believes that all persons in grades kindergarten through eighth grade who reside in the Rockaway Borough School District may attend District schools. All persons eligible for admission to the District's schools and who are domiciled within Rockaway Borough without a lease or deed must provide proof of domicile, in the form of a sworn statement.

If you are residing in the home or apartment of a Rockaway Borough OWNER without a lease and requesting admission of your child into the Rockaway Borough Schools, the attached affidavits must be completed and notarized prior to your child's admission. The first affidavit should be completed by the Rockaway Borough Resident that owns the home or apartment in which you reside and the second affidavit should be completed by the parent(s) of the student requesting admission in to the school district.
