Regular Public Meeting Thomas Jefferson School September 15, 2011

I. Call to Order and Flag Salute

The meeting was called to order at 7:32 p.m. by Board Vice – President, Debbie McNally.

II. Notice of Announcement

III. Roll Call

IV. Superintendent's Report

- 1. <u>Principal's Reports</u> Ms. Alpaugh and Ms. Rehman discussed the events that took place in their schools.
- 2. <u>Enrollment</u> Dr. Tierney informed the Board that we currently have 663 students.
- 3. Opening Day Dr. Tierney discussed the first day of school with the Board.
- 4. <u>Transportation</u> Dr. Tierney informed the Board and the public that the business office have received a quote for the Andrea Drive AM run, but it will not begin until September 27. Until that time we will have two busses pick up the children.
- 5. <u>NJASK- AYP</u> Dr. Tierney briefly discussed the report and told all people that an in depth report will be provided at the October Board of Education Meeting.

 - a. Classroom Doors Dr. Tierney explained that when the Fire Door Project was proposed to the State it included replacement of the fire doors and several classroom doors. Since the project was approved including the classroom doors, they want the Board to repair the classroom doors before they reimburse us for part of the project.
 - b. Lincoln School Roof Dr. Tierney informed that Board that while Kellen Chapin, himself and Mr. Hurley were on the roof, they noticed it needs repairs. Dr. Tierney and Mr. Hurley will meet with Kellen next week to discuss the project.
 - c. Lincoln Fire Escape Dr. Tierney explained that we were originally going to paint it, but then it turned out to need substantial repairs, which cost about \$77,000.
 - d. Lincoln Sewer Line Dr. Tierney informed the Board that the storm drain pipe is now going into the correct drain.

WHEREAS, on September 15, 2011 the governing body of the Rockaway Borough Board of Education, County of Morris, State of New Jersey duly considered participation in a Cooperative Pricing System for the provision and performance of goods and services;

NOW, THEREFORE BE IT RESOLVED as follows:

TITLE

This RESOLUTION shall be known and may be cited as the Cooperative Pricing Resolution of the Rockaway Borough Board of Education

AUTHORITY

Pursuant to the provisions of *N.J.S.A.* 40A:11-11(5), the Joseph P. Hurley Jr. is hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

CONTRACTING UNIT

The Lead Agency shall be responsible for complying with the provisions of the *Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.)* and all other provisions of the revised statutes of the State of New Jersey.

EFFECTIVE DATE

This resolution shall take effect immediately upon passage.

2. **WHEREAS**, the New Jersey School Boards Insurance Act, Assembly 1373, enacted and signed by the Governor in 1983, enables school districts to cooperate with each other to make the most efficient use of their powers and resources on a basis of mutual advantage in the areas of insurance and self-insurance and related services; and

WHEREAS, the Rockaway Borough Board of Education desires to secure protection, services, and savings relating to insurance and self-insurance for itself and its departments and employees; and

WHEREAS, the Rockaway Borough Board of Education finds that the best and most efficient way of securing this protection and services is by cooperating with other school districts across the State of New Jersey;

WHEREAS, the Rockaway Borough Board of Education under its obligations as a member of the New Jersey School Boards Association Insurance Group does allow for safety inspections of its properties, to pay contributions in a timely fashion and to comply with the bylaws and standards of participation of this Group.

NOW THEREFORE BE IT RESOLVED BY THE Rockaway Borough Board of Education:

THAT the Rockaway Borough Board of Education joins with other school districts in organizing and becoming members of the **ERIC WEST** Subfund a fund within the New Jersey School Boards Association Insurance Group; and

THAT, by adoption and signing of this resolution, the Board of Education is hereby joining the **ERIC WEST** Subfund a fund within the New Jersey School Boards Association Insurance Group effective the date indicated below, and for the duration of three consecutive years for all coverages bound during the policy year this resolution is adopted.

- 5. Be it resolved by the Rockaway Borough Board of Education to enter into an agreement with Morris Hills Regional High School to provide transportation for the Andrea Drive Route #1A. This contract will begin September 27, 2011 and end no later than June 30, 2012. The cost will be \$6,512.
- 6. Be it resolved by the Rockaway Borough Board of Education to approve Tara Renehan to provide Wilson Reading Instruction to student #122 for 2 hours per week at a rate of \$35.98. Ms. Renehan will begin 9/20/2011 and end no later than June 30, 2012.

Dr. Tierney said that he and Mr. Hurley will meet with Kellen Chapin next week to discuss the playground.

XIII. Comments from the Public

Mr. and Mrs. Morena pointed out that their child is one of 24 in their class. Such a large class size puts stress on the teachers and makes it hard for them to leave 1st grade with the required skills. Dr. Tierney and Ms. McNally said the Board hired a Reading Specialist to help focus on all 663 students, and not a general classroom teacher who would just help a portion of the first grade. The Reading Specialist will be able to pull students that need help out of class and work with them in small groups. This would not be accomplished if an additional first grade teacher was hired.

Mr. Morena asked why a sports program was reinstated when Rockaway Borough has an excellent recreation program. Ms. McNally said that it has an educational component and that it helps motivate kids to keep their grades up so they can participate.

Ms. Delle asked why kids cannot get up and move around during lunch and that it is like being in jail. Ms. Rehman said students spill lunches, are disrespectful to the aides, gossip and argue, which all lead to fights. Ms. McNally added that this is not the Board's intention, but the students must learn to be respectful. The Board will look into this practice.

XIV. Motion to Adjourn

There being no further business before the Board, a motion was approved at 9:04 p.m. to adjourn for the evening. (Smith/Lugo)
