Be it resolved, based upon the recommendation of the Superintendent & Business Administrator, to approve an "Educational Services Contract Agreement" with the NJ Department of Children and Families for the special educational out-of-district placement, in Westbridge Academy, for tuition, related services and transportation, for Student #197, effective July 1, 2018 to June 30, 2019 at a per diem rate of \$410.84 for tuition and per diem rate of \$135.20 transportation (total contract of \$101,017.40).

Relevant information: This student is a ward of the state thus all costs will be paid by NJDCF to us (100% reimbursement) as the student resides in our town. This is a renewal (for the 2018-19 school year) of this arrangement on an annual basis since the 2015-16 school year. We have been paying Westbridge Academy and the bus contractor and receiving reimbursements all along since July of this school year. This simply formalizes the arrangement.

17. Technology/Building & Grounds

A. Be it resolved, based upon the recommendation of the Business Administrator, to award a purchase order to Window Repair Systems, of Westminster, SC, to perform a "side load window reconstruction and screen install" by furnishing and installing new lower sash balancing systems and screens on 52 window units for the TJ Middle School, at \$487 per window unit, for a total cost of \$25,324 as per their quote dated January 11, 2019. This award is made under the proprietary goods exception (to seek other quotes) cited in NJAC 5:34-9.1 since this company has a US Patent on their specially made "Turbo 2 Class 5 Window Balancer" for this window system.

Relevant information: This is "round 2" of 5 rounds to fix the windows in TJ. This project was deleted from the Referendum Question #1 (prior to the vote) and is expected to be done during this coming Spring Break. Another round (#3) of window repair is recommended for the Summer of 2019 utilizing unspent 18-19 budget funds. It is most advantageous to have this company work on their windows and not have any other company touch their system.

This will enhance the lunch program at TJ by providing a new heater food cabinet. This purchase will be paid with cafeteria fund profits and thus, will be at no cost to the district or taxpayers.
