### 1. Call To Order

The meeting was called to order at 7:02 p.m., by Mrs. Christa Smith, Board President, by reading the following announcement to those present:

No action will be taken."

#### 3. Referendum II Public Forum: Information and Question & Answer Session

(A 24-minute video, which showed the dilapidated condition of the schools, played on the screen on the stage behind the Board for the entire time.)

The Board President made an opening statement in which she stated the focus of the referendum: enhance security (main entrance vestibules) and safety (new fire escape & updated fire/security alarms) and update old building machinery (new boilers, unit ventilators, roofs and electrical main panels). Then, the following facts and flyer was distributed and discussed: Net cost to the average home assessment of \$301,000 = \$250 per year, \$21/month, .68 Cents per day (or \$83 for every \$100,000 of your home's assessed tax valuation.) State aid will save \$81 per year. Without State Aid, the cost would have been \$331 per year, \$28/month, .91 cents per day. Are you a senior citizen? Do you know about the "NJ Senior Tax Freeze" Program? See if you qualify at:

The following residents, and others, asked various questions to the Board, Administration and professional advisors present: Al Morena, Danielle Wheelock, Mark Mckinney, Tony Gebbia and Brian Riveccio, among others. Some of the questions asked were: Why now? Can the bonds be issued all at once? Why did previous Boards kick the can down the road? What is the process to issue bonds? How long are the bonds paid? Why is steam heat bad? Why do we have to use prevailing wages when I can get my house fixed for much less? Why does the Lincoln fire escape need replacement? Can't we just keep the state aid without a referendum vote? If it passes, how long will it be to complete all the projects? How competitive are contractors in submitting realistic bids? How do the tariffs effect the project costs? Can't we just put the projects in the annual budget?

Is there any other avenues of revenue we can use except bonding? How much interest rate will the district pay on the bonds? Why can't we just ask the state or federal government for a free grant of money? How long did we have the trailers? How will the traffic flow be affected at Lincoln? Why do the lavatories need to be updated? Why do the electrical panels need replacement? How old is the roofs on the schools?

There were lively and sincere discussions throughout the evening. The Board president then thanked the people present, the professional advisors and the administration for such straightforward and knowledgeable information.
